Oreland Swim Club 2020 Operation Plan

OSC has developed a list of guidelines to help maintain a safe environment for all members during the summer of 2020. OSC management and staff will be monitoring pool facilities and safety, but we ask for our members, *especially our parents*, to monitor their own families in upholding these guidelines. Educating and reinforcing social distancing is important!

The OSC operation plan will be reviewed as state and local guidelines change.

- 1) OSC members should follow all guidance and requirements set by the CDC, local government, and health experts during the course of their visit: most importantly, members may not utilize the facility when sick or recently exposed to COVID or have a personal health situation which causes concern. Members should wash hands often with soap and water or use the club provided or personal hand sanitizer.
- 2) Members should adhere to social distancing guidelines on grounds, in restrooms, and at Splash Café.
- 3) Only family members are permitted to sit in a group. Groups must be 6 feet apart from other family groups.
- 4) Although not required, a face covering is recommended when social distancing becomes difficult. Face coverings are not permitted in the pool when swimming due to possible drowning concerns.
- 5) At this time, we **will not** be allowing non-member guests at the swim club. If you purchased a guest pass you may request a refund via email.
- 6) The club will not be providing sporting equipment which includes goggles for loan. We encourage members to bring their own from home. Please bring your items home with you!
- 7) Members' pool chairs must be brought to and from the pool. Storing chairs at the pool will not be permitted at this time.
- 8) Diving Well Guidelines members should maintain social distance by standing on the spacing markers posted on the deck. There will be no "free swims" until further notice.
- 9) Baby Pool Guidelines A child must be closely supervised by a parent to maintain social distance. Parents should use discretion regarding capacity. Pool toys must be taken home by the member each day. They will not be kept overnight and discarded if forgotten.
- 10) Main Pool Guidelines on busy days we may need to limit people in the main pool if social distancing becomes difficult.
- 11) Lap Lane Guidelines Lap swimming will be monitored for compliance with USA Swimming Guidelines
- Please avoid unnecessary time in the locker room by A) coming to the club changed and ready to swim and B) taking a shower and changing from your swim at home.
- 13) Bathrooms, changing rooms, and common touch areas (counters, knobs, etc) will be disinfected frequently during the pool operational hours and again before reopening for the next day.

- 14) The pool deck and perimeter edge are to remain clear for easy bather and lifeguard access to the water. Please set up your family on the spacious lawns and not the deck.
- 15) The staff will be monitored for symptoms.
- 16) Lifeguards will focus on their lifeguarding duties and will not be assigned any other task while on lifeguard duty. Pool safety is their utmost concern. Lifeguards will wear masks and gloves when performing first aid duties.
